#### 2.9 BHS Math and VoEd/Arts Teacher Temporary Stipends - Mrs. Hernandez

Temporary stipends are needed for additional duties for two teachers at BHS that will create lesson plans for substitute teachers.

#### 2.10 BHS Assistant Principal Temporary Stipend - Mrs. Hernandez

#### 2.12 BHS Course Requests and Graduation Requirements - Mr. Tohtsoni

NMPED is requiring new graduation requirements for the Class of 2029/Cohort 2025 to include an increase in Social Studies credits to 4 credits, and a mandated 2 credits that School Districts decides on. NMPED removed the Algebra 2 and NM History requirement, as NM History is included in US History. NMPED removed the AP/Dual Credit/Honors/Distance Learning requirement and no longer requires a cut score for SATs. Requesting approval of new requirements for graduation. Requesting approval of new courses to align with the new requirements. Requesting approval of new courses to align with Career and Technical Education pathways form NMPED.

#### 2.13 Indian Policies and Procedures - Dr. Julie Pierce
