ELECTION PROCLAMATION AND RESOLUTION

WHEREAS, the Board of Education, as governing board (the “Board”) of Bloomfield Municipal School District No. 6, County of San Juan, State of New Mexico (the “District”), has determined, and does hereby determine, upon its own initiative to submit to an election the question regarding the issuance of general obligation bonds in the maximum amounts and for the purposes hereinafter specified at a special all mail ballot Election on Tuesday, August 20, 2024, in accordance with Section 1-16-3(C), NMSA 1978, Sections 1-24-1 et seq., and Section 22-18-1, NMSA 1978, as amended; and

WHEREAS, it is the opinion of the Board that it is necessary and in the best interests of the residents of the District that there be submitted to a vote of the registered qualified electors of the District, the question of whether the District should issue its general obligation bonds for the purposes hereinafter specified; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BLOOMFIELD MUNICIPAL SCHOOL DISTRICT NO. 6, COUNTY OF SAN JUAN, STATE OF NEW MEXICO AS FOLLOWS:

Section 1. The Board does hereby propose that the following question be included on the special election ballot and submitted to the registered qualified electors of the District, at the special all mail ballot election on Tuesday, August 20, 2024:

Section 2. The Superintendent of the District, (an “Authorized Officer”) is hereby authorized and directed to deliver a copy of this Resolution to the San Juan County Clerk. Pursuant to Section 1-24-2 (A)(1) NMSA 1978, the San Juan County Clerk is hereby requested to certify the foregoing ballot question to the Secretary of State not less than sixty-seven (67) days prior to the election. NMSA 1978, 1-24-2 (A)(3), as amended.

Section 3. The Authorized Officer is hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

Section 4. If any section, paragraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this resolution.

Section 5. All resolutions and ordinances, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any resolution or ordinance, or parts thereof, heretofore repealed.

Section 6. All action heretofore taken by the Board and officers of the District not inconsistent with the provisions of this Resolution and directed toward the calling and conducting of the Election be, and the same hereby is ratified, approved and confirmed.
