New this year is Wacky Wednesdays which allows core teaching staff to utilize the first 2 hours of every Wednesday to dissect, direct and evaluate data. During this time, students are given the chance to experience something different. Students rotate to the elective and support staff and they get to experience new skills, activities and make new memories. With the changes for this year is Funday Fridays which included homecoming and Halloween events.
