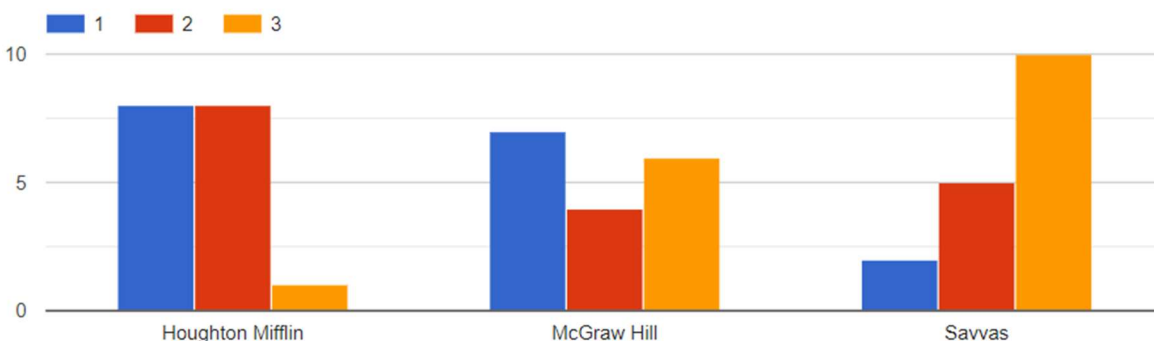
2. Vendor presentations – The vendor presentations were publicized through the October 12, 2021 board meeting and public notice via the district website on 10/25/2021. Invitations for individuals from the public to participate were a part of the notice. **Seventeen volunteer teachers** participated in all three vendor sessions via Zoom. Physical materials were provided to each site for all teachers to review. Each participant completed an adoption rubric and final Ranking of Publishing Materials by Quality form following the presentations.

- November 15 – HMH 3:00-4:00 K-5; 4:00-5:00 grades 6-8
- November 16 – McGraw Hill 3:00-4:00 K-5; 4:00-5:00 grades 6-8
- November 17 – Savvas 3:00-4:00 K-5; 4:00-5:00 grades 6-8

3. Rubric averages for each of the vendor presentations are as follows:

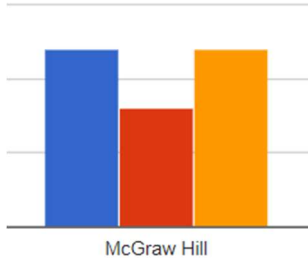
- HMH - average rubric score **78**
- McGraw Hill – average rubric score **74**
- Savvas – average rubric score **71**

4. Final ranking scores are as follows showing Houghton Mifflin as the highest ranked vendor:

Five of the seventeen teachers represented BECC. 100% selected McGraw Hill as their top choice when final ranking forms were completed. The decision was made to recommend that BECC adopt McGraw Hill “Wonders”.



The consensus recommendation from the remainder of teachers on the committee was to select Houghton Mifflin “Into Reading”/”Into Literature” for grades 1-8. This will provide effective alignment with grades 9-12 as they adopted HMH last year.

McGraw Hill (Kindergarten ONLY):

There is a 1 set per 22 student purchase ratio at a cost of \$5216 per set. Currently, there are 8 classroom teachers and 3 sped teachers who will need materials. Purchase will be for 179 students. To accommodate all staff/students, 9 sets will be purchased in addition to three teacher’s editions for a total cost of **\$54,211.46**.
